# Two-photon processes at Belle

#### Abstract

We review recent measurements of pure neutral final state production in the two-photon processes, $\gamma \gamma \rightarrow \pi^{0} \pi^{0}$ and $\eta \pi^{0}$ at the Belle experiment. In the lower invariant mass region, properties of light scalar mesons are measured by partial wave analysis. In the higher energy region the total and differential cross section are compared with QCD models.

## 1 Introduction

Two-photon production of exclusive hadronic final states provides useful information about resonances and pertubative and nonperturbative QCD. From theoretical viewpoint, two-photon process is attractive because of the absence of strong interactions in the initial state and the possibility of calculating $\gamma \gamma \rightarrow q \bar{q}$ amplitudes. In addition, the quantum numbers of the final state are restricted to states of charge conjugation $C=+1$ with $J=1$ forbidden. This feature enables us to do complementary measurement to $\mathrm{e}^{+} \mathrm{e}^{-}$annihilation process where mesons with $C=-1$ and $J=1$ are produced exclusively.

We have measured charged pion pair [1-3], charged kaon pair [1, 4], neutral kaon pair [5], proton antiproton pair [6] and $D$-meson pair [7] production in two-photon collisions. The statistics of these measurements is 2 to 3 orders of magnitude highter than in the pre- $B$-factory measurements, opening a new era in studies of two-photon physics.

In this report, we summarize measurements of neutral final state production, $\gamma \gamma \rightarrow \pi^{0} \pi^{0}$ and $\eta \pi^{0}$. We use the data samples of $95 \mathrm{fb}^{-1}[8]$ and $223 \mathrm{fb}^{-1}$ [9] for $\gamma \gamma \rightarrow \pi^{0} \pi^{0}$ and of $223 \mathrm{pb}^{-1}$ for $\gamma \gamma \rightarrow \eta \pi^{0} \quad[10]$ collected with the Belle detector [11] at the energyasymmetric $\mathrm{e}^{+} \mathrm{e}^{-}$KEKB collider [12].

## 2 Derivation of differential cross sections

The differential cross section for pair production
in two-photon collision, $\gamma \gamma \rightarrow \mathrm{h} \overline{\mathrm{h}^{\prime}}$ is obtained by

where $\Delta Y$ and $\Delta B$ are the numbers of signal and background events, respectively, found in a bin width of the two-photon invariant mass $\Delta W$ and $\Delta\left|\cos \theta^{*}\right|$ with $\theta^{*}$ a scattering angle of h with respect to the gamma beam in two-photon center of mass system, $\epsilon\left(W,\left|\cos \theta^{*}\right|\right), L_{\gamma \gamma}(W)$ and $\int L \mathrm{~d} t$ are the efficiency, luminosity function and integrated luminosity, respectively.

## 3 Event selection

To reconstruct $\pi^{0}$ and $\eta$, photons are detected and measured in an electromagnetic calorimeter (ECL) which is an array of $8736 \mathrm{CsI}(\mathrm{Tl})$ crystals pointing toward the interaction point. Signals from ECL are also used to issue an energy trigger which requires total energy deposit greater than 1.15 GeV , or a four or more cluster trigger each of which is required to have energy larger than 110 MeV .

Our analysis is based on the "zero-tag" mode, where by collecting small total transverse momentum events, $\left|\sum \vec{p}_{\mathrm{t}}\right|<0.05 \mathrm{GeV} / c$, the incident photons are guaranteed to have small virtuality. Under this condition, beam $\mathrm{e}^{+} \mathrm{e}^{-}$particles are supposed to escape through the beam pipes with small scattering angle and hence the photon-photon collision axis is approximated with the $\mathrm{e}^{+} \mathrm{e}^{-}$beam axis.

[^0]We estimate the fraction of background events by comparing the $\left|\sum \vec{p}_{\mathrm{t}}\right|$ distribution between data and signal Monte Carlo (MC) events, and subtract them from data in each $\Delta W-\Delta\left|\cos \theta^{*}\right|$ bin.

## 4 Light scalar resonance study

We perform fits to the differential cross section in the $W$ regions of $0.8 \mathrm{GeV}<W<1.6 \mathrm{GeV}[8]$ and $1.7 \mathrm{GeV}<W<2.5 \mathrm{GeV}[9]$ for $\gamma \gamma \rightarrow \pi^{0} \pi^{0}$, and $0.9 \mathrm{GeV}<W<1.46 \mathrm{GeV}$ for $\gamma \gamma \rightarrow \eta \pi^{0}[10]$, and the angular region of $\left|\cos \theta^{*}\right|<0.8$, using

where $D_{0}$ and $G_{0}\left(D_{2}\right.$ and $\left.G_{2}\right)$ denote the helicity 0 (2) components of the $D$ and $G$ waves, respectively, and $Y_{J}^{m}$ 's are the spherical harmonics. Each wave consists of resonance term, e.g.,

where $\Gamma_{\gamma \gamma}(R)$ and $J$ are the two-photon decay width and spin for the resonance $R$, respectively, and the coherent background term assumed to be quadratic in $W$.

## $4.1 \quad \gamma \gamma \rightarrow \pi^{0} \pi^{0}$

The differential cross section is calculated using Eq. (1) with the efficiency estimated from a signal MC study.

Figure 1 shows the total cross section integrated over $\left|\cos \theta^{*}\right|<0.8$. We observe clear peaks for the $\mathrm{f}_{0}(980)$ near 0.98 GeV and the $\mathrm{f}_{2}(1270)$ near 1.25 GeV and find at least two more structures around 1.65 and 1.95 GeV .

In the fit to the lower energy region $0.8 \mathrm{GeV}<$ $W<1.6 \mathrm{GeV}$ where $S, D_{0}$ and $D_{2}$ waves are considered, in addition to $f_{0}(980), f_{2}(1270)$ and $f_{2}^{\prime}(1575)$ we introduce a scalar meson $\mathrm{f}_{0}(\mathrm{Y})$ to take into account a resonance-like structure around 1.2 GeV seen in $\hat{S}^{2}$ in Fig. 2, which can be either the $f_{0}(1370)$ or $f_{0}(1500)$ or a mixture of them.

We obtain the fraction of the $\mathrm{f}_{2}(1270)$ component in the $D_{0}$ wave, $r_{02}=\left(3.7 \pm 0.3_{-0.29}^{+15.9}\right) \%$ and $\mathcal{B}\left(\mathrm{f}_{2}(1270) \rightarrow \gamma \gamma\right)=\left(1.57 \pm 0.01_{-0.14}^{+1.39}\right) \times 10^{-5}$. Inclusion of both non-zero value of $r_{02}$ and $\mathrm{f}_{0}(\mathrm{Y})$ is favored over absense of $r_{02}$ and/or $\mathrm{f}_{0}(\mathrm{Y})$. Other fit results are summarized in Table 1.

In the fit to $1.7 \mathrm{GeV}<W<2.5 \mathrm{GeV}$ where the $G$ wave contributions are nonzero and are dominated by the $G_{2}$ wave, we assume $\mathrm{f}_{4}(2050)$ in the $G_{2}$ wave with its paremeters floated. Since the $G_{2}$ wave interferes with the $D_{2}$ wave, we include the resonance $\mathrm{f}_{2}(1950)$, which is known to couple to two photons. Here we denote it as the " $\mathrm{f}_{2}$ (1950)" assuming that the $\mathrm{f}_{2}(1950)$ is just an empirical parameterization representing any possible resonances in this $W$ region [17]. For $\left|\cos \theta^{*}\right|<0.7$, the $\left|Y_{4}^{0}\right|^{2}$ and $\left|Y_{4}^{2}\right|^{2}$ terms are nearly equal, so we show $\hat{G}_{0}^{2}+\hat{G}_{2}^{2}$ and $\hat{G}_{0}^{2}-\hat{G}_{2}^{2}$ instead.

The resulting spectra are shown in Figs. 3 and 4, and obtained parameters are listed in Table 1. The
$M\left(\mathrm{f}_{4}(2050)\right)$ and " $M\left(\mathrm{f}_{2}(1950)\right)$ " flip and the widths are about two times larger than their PDG values. Further fit studies reveal that the fits with $f_{4}(2050)$ parameteres fixed or without " $\mathrm{f}_{2}(1950)$ " are disfavored compared to the nominal fit, and a more reasonable fit is obtained when two more parameters are introduced in the $G_{2}$ background. Although a more sophisticated model is necessary, our data clearly require a $G$-wave component, and the unacceptably worse fit without the $f_{4}(2050)$ strongly supports its finite two-photon coupling.

## $4.2 \quad \gamma \gamma \rightarrow \eta \pi^{0}$

Figure 5 shows the cross section integrated over $\left|\cos \theta^{*}\right|<0.8$ on logarithmic and linear scales for partial $W$ regions. The data points are in good agreement with those from Crystal Ball [13]. We find three resonant structures: near $0.98 \mathrm{GeV}\left(\mathrm{a}_{0}(980)\right)$, $1.32 \mathrm{GeV}\left(\mathrm{a}_{2}(1320)\right)$ and 1.7 GeV (probably the $\mathrm{a}_{2}(1700)$ ). We focus on the region, $W<1.5 \mathrm{GeV}$,
where $J>2$ waves can be safely neglected, because a fit with $\mathrm{a}_{2}$ (1320) parameters doesn't give a stable result. Introducing $\mathrm{a}_{0}(\mathrm{Y})$ to model the shoulder around 1.2 GeV in the $\hat{S}^{2}$ wave, we fit differential cross sections for the range $0.90 \mathrm{GeV}<W<1.46 \mathrm{GeV}$ (Table 1).

In case the $\mathrm{a}_{2}(1320)$ parameters are floated, we obtain $\mathcal{B}\left(\mathrm{a}_{2}(1320) \rightarrow \gamma \gamma\right)=(9.4)_{-2.2}^{+6.3} \times 10^{-6}$.

## 5 Analysis of the higher-energy region

The leading-order QCD calculation [14, 15] predicts $\mathrm{d} \sigma\left(\pi^{0} \pi^{0}\right) / \mathrm{d} \sigma\left(\pi^{+} \pi^{-}\right) \approx 0.07$ at $\left|\cos \theta^{*}\right|=$ 0 , changing to $\approx 0.4$ at $\left|\cos \theta^{*}\right|=0.6$, and $\mathrm{d} \sigma\left(\eta \pi^{0}\right) / \mathrm{d} \sigma\left(\pi^{0} \pi^{0}\right)=0.46\left(\mathrm{f}_{\eta} / \mathrm{f}_{\pi^{0}}\right)^{2}$ where $\mathrm{f}_{\eta}\left(\mathrm{f}_{\pi^{0}}\right)$ is the $\eta\left(\pi^{0}\right)$ form factor, while $\mathrm{d} \sigma\left(\pi^{0} \pi^{0}\right) / \mathrm{d} \sigma\left(\pi^{+} \pi^{-}\right)=0.05$ by the handbag model [16]. We can evaluate these predictions at $W>2.4 \mathrm{GeV}$ where the contribution from resonances is small.

## $5.1 \quad \gamma \gamma \rightarrow \pi^{0} \pi^{0}$

The normalized differential cross section for selected four $W$ points is shown in Fig. 6(a) where the fit function

is used. Above $W=3.1 \mathrm{GeV}$, the $\sin ^{-4} \theta^{*}$ dependence $(b=0)$ is also acceptable. The $W$ dependence of $b$ is shown in Fig. 6(b). The cross sections $\sigma\left(\pi^{0} \pi^{0}\right)$
and $\sigma\left(\pi^{+} \pi^{-}\right)$, and their ratio which is found to be $0.32 \pm 0.03 \pm 0.05$ for $3.1 \mathrm{GeV}<W<4.1 \mathrm{GeV}$, are shown in Fig. 7. The power-law $W^{-n}$ dependence parameter of the total cross section $\left(\left|\cos \theta^{*}\right|<0.8\right)$ is obtained to be $n=8.0 \pm 0.5 \pm 0.4$.

## $5.2 \gamma \gamma \rightarrow \eta \pi^{0}$

The angular dependence is in agreement with $\sin ^{-4} \theta^{*}$ for $W>2.7 \mathrm{GeV}$. The fit with $W^{-n}$ gives $n=10.5 \pm 1.2 \pm 0.5$. The $n$ values are summarized in Table 2. The ratio $\mathrm{d} \sigma\left(\eta \pi^{0}\right) / \mathrm{d} \sigma\left(\pi^{0} \pi^{0}\right)$ is consistent with leading-order calculation of 0.46 if $\mathrm{f}_{\mathrm{\eta}} / \mathrm{f}_{\pi^{0}}$ is 1 .

## 6 Conclusion

We have measured the diffential cross sections of the two-photon production of pure neutral final states, $\gamma \gamma \rightarrow \pi^{0} \pi^{0}$ and $\eta \pi^{0}$, using a high-statistics

data sample collected with the Belle detector at the KEKB accelerator. We perform the partial wave analyses in the lower energy region to extract properties of the light scalar mesons.

For $0.8 \mathrm{GeV}<W\left(\pi^{0} \pi^{0}\right)<1.6 \mathrm{GeV}$ a model including $S, D_{0}$ and $D_{2}$ waves is tested. The $\mathrm{f}_{0}(\mathrm{Y})$ is necessary in the $S$ wave in addition to the known
$\mathrm{f}_{0}(980), \mathrm{f}_{2}(1320)$ and $\mathrm{f}^{\prime}(1525)$ mesons. Our data favor inclusion of $f_{0}(Y)$ and $f_{2}(1270)$ contribution to the $D_{0}$ wave. For $1.7 \mathrm{GeV}<W\left(\pi^{0} \pi^{0}\right)<2.5 \mathrm{GeV}$, a contribution of the $\mathrm{f}_{4}(2050)$ is significant in the $G$ wave. We introduce $\mathrm{a}_{0}(\mathrm{Y})$ to model $\mathrm{d} \sigma / \mathrm{d}\left|\cos \theta^{*}\right|$ for $0.9 \mathrm{GeV}<W\left(\eta \pi^{0}\right)<1.46 \mathrm{GeV}$ in the fit using $S, D_{0}$ and $D_{2}$ waves.

In the higher energy region, QCD predictions are compared to the data. The $\sin ^{-4} \theta^{*}$ dependence of the differential cross section is in agreement with the observed data above $W=3.1(2.7) \mathrm{GeV}$ for $\gamma \gamma \rightarrow$
$\pi^{0} \pi^{0}\left(\eta \pi^{0}\right)$ but an additional $\cos ^{2} \theta$ term gives a better fit to the $\pi^{0} \pi^{0}$ data in the $2.4-4.1 \mathrm{GeV}$ region. The power-law dependence of the total cross section, $\sigma \propto W^{-n}$ and their ratios are presented.
